The cost for golf will be \$40.00 per person, which includes green fees, cart and prizes. Tee times will begin at 12:02 p.m. and it would be appreciated if all golfers would arrive at least 30 minutes prior to their assigned tee times.

As a fundraiser for H.E.L.P. Legal Aid, participants may each purchase two "mulligans" and 3 inches of "putting string" for a donation of \$25.00 per person. Please make out a separate check to "**H.E.L.P. Legal Aid**" if you wish to have a separate record for tax deductibility. Otherwise, please add \$25.00 to your green fees.

After golf, an informal steak dinner inside the Palmer Hills Grill will be available to participants and non-participants alike at the Palmer Golf Course Grill starting at 5:30 p.m. The cost for the dinner will be \$20.00. New members of the Scott County Bar Association may attend the dinner as guests of the Association. The Association will purchase one keg of beer and there will also be a cash bar for the purchase of other refreshments.
