### **Lawyer Referral Service Information**

The Scott County Bar Association Lawyer Referral Service is operated and sponsored by the Scott County Bar Association. It refers individuals who are seeking an attorney to participating bar members. During the past year, there have been 10 attorneys in the association who have participated. During this time, there have been over 1,282 referrals made to these participating attorneys.

Attorneys who participate agree to provide an initial one-half hour consultation for a fee not to exceed \$20.00. Thereafter, any additional services and fees are matters to be negotiated between the attorney and the referred client. The cost of the participation in this service is \$55.00 per year. Registration fee is waived for 1<sup>st</sup> year members of the Scott County Bar Association.

Attorneys are encouraged to participate in the Lawyer Referral Service. The service provides a public service to persons seeking legal assistance. Fees can be charged as outlined above.
